Scope of Work: -

The scope of work for the job is as follows:

I	Arrangement for Survey of the Indoor type Sub-Station for exploring and understanding the Scope of Work for Replacement of Main Electrical Low Tension Panel Board of the ICMARD Building.
II	Arrangement for Detailed Electrical Load Survey (Floor-wise) of the ICMARD Building and submission of Report against it both in soft and hard mode.
III	Preparation & submission of Detailed Drawings of new Electrical Low Tension Panel Board [CPRI approved] of the ICMARD Building including in-built 150 KVAR APFC Capacitor Bank and its Panel. The prepared Drawing should be submitted both in Hard mode (Colour Printed) as well as in Soft mode (in .dwg format).
IV	Preparation of Estimate (Scope of Work including approximate cost) based on the Schedule of Rates for Electrical Works, Volume – I, November, 2017, PWD, Govt. of West Bengal, in case of PWD Scheduled Items and based on present market rate in case of PWD Non-Scheduled Items for Replacement of Main Electrical Low Tension Panel Board [CPRI approved] of the Building including in-built 150 KVAR APFC Capacitor Bank and its Panel and submission of the said Estimate both in soft and hard mode.

A. General Instructions and Terms & Conditions: -

1. The Bidder/Agency is expected to read all instructions, terms & conditions, specifications in the EOI documents before submission of Bid.
2. The Drawing and Estimation of the new Electrical Low Tension Panel Board [CPRI approved] of the Building including in-built 150 KVAR APFC Capacitor Bank and its Panel should be prepared in accordance with the requirements for obtaining approval from Central Power Research Institute (CPRI).
3. **Submission of Bid:-**
 - a. The Technical Bid should contain all the EOI documents and supporting proof. The agencies have to fill up the Annexures with their signatures along with all supporting documents.
 - b. The Financial Bid should contain price Bid only as per attached BOQ.
 - c. Bid Validity Period / Validity of the Bid Offer should be 90 (Ninety) Days from the last date of submission.
3. The Bank may, at its discretion, extend last date for the submission of Bids by amending the Bidding Documents.
4. **Pre-qualification Criteria of Bidder:**
 - a. The Bidder should have minimum 03 (Three) years' experience of 'Consultancy Service for Electrical Load Survey; Designing & Estimation of Electrical Panels & System in Commercial Buildings' for reputed Govt. / Public Sector Enterprise / Banks / other reputed agencies. **Work Order with Performance Certificate or Completion Certificate** in this regard should be submitted. Any job executed by the Bidder for its own In-House purpose/Sister Concern/Subsidiary shall not be considered as relevant experience. Also, job executed by the Bidder as an Authorized Dealer/Subsidiary/Fellow Subsidiary/Holding Company and Sub-Contractors shall not be considered as relevant experience.
 - b. The Bidder should submit Self-Certified copy of GST Registration Certificate & PAN.
 - c. The Bidder should sign each and every page of the EOI document and Application Form & ANNEXURES as an acceptance of the conditions of the contract and submit it along with the credentials with office seal.
 - d. The Bidder should have its Registered Office in West Bengal.
 - e. The Bidder must submit Self-certified Copy of valid and relevant **Licenses** (License to Electrical Contractors and Electrical Supervisor's Certificate of Competency; Parts Qualified: 1, 2 & 11 of West Bengal Electricity Licensing Board) and **Registration**.

- f. The **Annual Report** of the last three years of the Bidder must reflect profitability.
 - g. The Bidder was not be banned / blacklisted ever in any institution / organization.
 - h. The Bidder must submit copy of valid **Trade License**.
 - i. Relevant documents supporting eligibility criteria are to be submitted along with the Technical Bid.
 - j. In case of Partnership Firm/ Company, the Bidders are required to submit copy of Partnership Deed/Memorandum of Association (MOA)/Article of Association (AOA)/Certificate of Incorporation & Copy of Registered Power of Attorney.
 - k. The Bidder must submit details of its Technical Persons with Technical qualification, who would be deputed for the job.
5. The Bids of the participants will be summarily rejected **on noncompliance & non-fulfilment** of the Pre-Qualification Criteria in **Sl. No. 04**.
 6. The successful Bidder must submit on Letter Head names of their **authorized personal to be deputed** to have technical discussion & presentation before the authority of The WBSCARD Bank Ltd. with a prior written intimation to The WBSCARD Bank Ltd., after placement of Work Order.

B. Evaluation of Bid:

Technical Evaluation: All the documents in support to the eligibility criteria mentioned will be evaluated. If the required documents as prescribed above are not submitted, then the offer will be summarily rejected. Based on the evaluation, the valid Technical Bids will be scrutinized to shortlist eligible agencies.

The Financial Bids of the only Technically Qualified Bidders will be opened.

Financial Evaluation:- The financial Bid should be submitted in the prescribed format.

Note: The Technically Qualified Bidder with Lowest Price will be awarded with the Contract. However, the Bank is not bound to accept the Lowest Bid. The Bank reserves the right to accept or reject any or all Bids without assigning reasons thereof.

C. Time for Completion of the Work: -

The successful Bidder will be given **20 (Twenty) Days'** time period from the Date of issuance of Work Order to complete the entire work as described in the Scope of Work. For any delay beyond the stipulated time frame for completion of work, **compensation** has to be paid by an amount equal to **1% (One Per Cent)** of the contract value or such any amount that may be decided by the appropriate authority of The WBSCARD Bank Ltd.

D. Payment & other Terms:

- a. After successful accomplishment of the entire work as mentioned under Scope of Work, payment will be released on submission of Invoice/Bill in duplicate and on submission of requisite documents both in soft & hard mode.
