## CORRIGENDUM

In reference to the **Notice Inviting Expression of Interest (e-EOI)** issued by The WBSCARD Bank Ltd. under **Memo No. 2510/97 dated April 22, 2026** & uploaded in the e-Tender Portal under **Tender ID 2026\_SCARD\_1023678\_1** inviting Bids from the experienced, resourceful and reputed Insurance Companies/ TPAs/ Insurance Brokers for providing **Group Mediclaim Policy** for the Permanent Employees including their dependent Family Members and Contractual Employees (Assistant) of The WBSCARD Bank Ltd., it is hereby notified that in the **Annexure III** of the said EOI containing list of Permanent Employees & their dependent Family Members and Contractual Employees (Assistant) of The WBSCARD Bank Ltd. to be covered under the aforesaid Group Mediclaim Policy, while mentioning name of **Sri Debasish Dasgupta**, Manager and his Dependent Family Members [ **Sl. No. 55, Employee ID 184** ], name of his **Grand Mother, Smt. Basanti Bose (Age 71 Years)**, was **inadvertently included**.

Since, **Grand Mother** of a Permanent Employee of The WBSCARD Bank Ltd. is **not eligible** for inclusion in the aforesaid **Group Mediclaim Policy** as per provisions in the Service Rules of The WBSCARD Bank Ltd., name of **Smt. Basanti Bose, Grand Mother of Sri Debasish Dasgupta [ Sl. No. 55, Employee ID 184 ]**, has been decided **to be excluded** from the List of Permanent Employees & their Dependent Family Members and Contractual Employees (Assistant) of The WBSCARD Bank Ltd. to be covered under the aforesaid Group Mediclaim Policy resulting in reduction in number of Dependent Family Members of **73 (Seventy Three)** number of Permanent Employees of The WBSCARD Bank Ltd. to **166 (One Hundred Sixty Six)** from earlier **167**. However, number of **Contractual Employees** remains the same at **19 (Nineteen)**.
